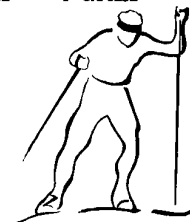

In consideration for the right to participate in Minneapolis Ski Club activities, including nordic skiing (ski jumping and cross country), training, officiating at events, working on training and event site preparation, and for the services being provided by *the Minneapolis Ski Club, the United States Coaches Association, the sponsors, and any coach, representative, officer, employee, member or affiliate of those organizations or Three Rivers Parks, Ramsey County Parks, Lake Elwood, all Washington Co Parks and Stillwater City Parks (collectively "the Entities")*, I hereby acknowledge, agree, promise and covenant as follows:

I understand and acknowledge that nordic skiing is an action sport carrying significant risk of serious personal injury, illness, death or property damage to me or to spectators or others. I also know that there are natural, mechanical and environmental conditions and risks which independently or in combination with my activities may cause property damage, or severe or even fatal injuries to me or others. I understand that the risks may include: negligent acts or omissions, latent or apparent defects in equipment or facilities, operation of equipment, weather conditions, acts of other participants, my own physical condition, condition of trails or terrain, first aid or emergency treatment and consumption of food or drink. I further understand that the above list may not be complete.

Being thus fully aware of the risks, both foreseen and unforeseen, I accept all risks and agree that I alone am responsible for my safety while participating in Minneapolis Ski Club activities and specifically acknowledge that **the Entities** are not responsible for my safety. I acknowledge that my participation is purely voluntary and I elect to participate in spite of the risks.

I SPECIFICALLY AGREE TO WAIVE, RELEASE and DISCHARGE, in advance, **the Entities** from any and all liability, claims, actions or rights of action, whether known or unknown, which may in any way arise in connection with my participation in Minneapolis Ski Club activities, INCLUDING SPECIFICALLY BUT NOT LIMITED TO ANY NEGLIGENCE OR FAULT ON THE PART OF **THE ENTITIES**.

I further agree, promise and covenant to HOLD HARMLESS and INDEMNIFY **the Entities** and each of them, from any and all defense costs, including attorneys fees, or any other costs in connection with any claims for injury or property damage resulting in any way from my participating in Minneapolis Ski Club activities.

I agree that I will accept and abide by the rules and decisions imposed by the organizers of the Minneapolis Ski Club. I also grant full permission to the Minneapolis Ski Club and all sponsors, and anyone authorized by them, to use any photographs, videotapes, motion pictures, recordings, or any other record of this event for any purpose.

I understand and agree that by signing this document, I have given up certain legal rights or possible claims that I might otherwise maintain. I understand and agree that this Acknowledgment of and Assumption of Risk and Release and Covenant shall be binding upon my heirs, assigns, personal representatives and estate, and that it cannot be modified by or changed by representations of any agent of **the Entities** or by me.
